Vapor Project Update

Rob Gregory spoke regarding the following topics:

- Congratulations to AY102 completion
- Thank you CVST for your support, remind people of the journey
- Highly contaminated waste was removed SAFELY, great accomplishment
- Litigation update, moved to March 2018 to allow for mediation
 - Mediator has been agreed upon
 - To begin April/May timeframe
 - We are hopeful to get out of litigation
- Cartridge Testing
 - AP Farm 3rd party impressed and have put in writing transition from Selfcontained breathing apparatus (SCBA) to Powered Air Purifying Respirator (PAPR)
 - We have final concurrence in process so that we can transition
 - Will then go to Mr. David Molnaa so that it can be incorporated into Memorandum of Agreement (MOA)
 - Looking for as early as week of March 6
 - Goal is to get the new process dialed in to get back to work, focus on AP, then considering SY, AY, AZ
 - All testing has been non waste disturbing with goal to be waste disturbing
- Mr. Geary will walk us through the transition to Vapors Management Plan
 - This will lay out the next couple of years

 - o IH Safety Flash will be issued
 - o We have full IHT and HPT coverage on all excavation jobs
 - o Jennifer Hayden gave presentation March 2016.
 - o There are at least 2/3 scenarios where Vapor boundaries are being requested to be moved, nothing has been approved
 - They will be proposed to all stake holders first (Molnaa) and provide basis for each scenario

Comprehensive Vapors Management Plan – Jim Geary

- Discussion:
 - o Originally was going to be TVAT Phase II but became much larger with greater interaction, thus evolved into this Plan
 - CPPO will be generating PERS per recommendations of all external reporting agencies
 - o Head space sampling we will try during waste disturbing activity, targeting evaporator, both before, during and after
 - Ongoing efforts include increasing staff to back fill positions, exposure evaluations, statistics, that is all part of the proposal as well as working with PNNL to provide analytical understanding to develop a better understanding for the workers
