Vapor Overview/Update – Rob Gregory, COO

- Reiterates Safety

- Cartridge testing 3rd party completed preliminary reports on 8 separate locations. Positive remarks, and are targeted to be back onsite early August.

- Have implemented active ventilation on AP Farm
- Review previous question regarding potential use of air-line use in the farms. WRPS has conducted a mock-up at HAMMER, which went fairly well, and has raised the potential of air-line use in close, small-crew evolutions. A pilot evolution may be planned.
 - Carry Air seems to be an increasing preferred option. If the application and desire continues, management may increase the availability of carry-air.
 - Feedback from the field indicates that not everyone is trained, and therefore, additional training may need to be included
 - Also may need to increase our supplies of carry-air
